NORTH CAROLINA HOUSE BILL 918

TO AMEND ABUSE, NEGLECT AND DEPENDENCY LAWS & EXPEDITE PERMANENCY

Substance abuse and particularly, opioid addiction, has occurred at historically high rates in North Carolina. Paying a very steep price in this epidemic are babies and small children in the care of parents who are too incapacitated to care for them. This is one reason the number of children entering the North Carolina foster care system has reportedly increased over 36% in the last decade.





Do you know about proposed legislation – House Bill 918
-- that has been making its way through the NC General
Assembly to try and address the situation? It is a childcentered bill intended to amend the child welfare statutes on
abuse and neglect and, as a result, would speed up placement
permanency for babies who are born to addicted mothers and
children living with parents who abuse illegal substances.

HB 918 aims to make 3 major changes in current laws:

- 1. Define illicit drug use during pregnancy as child abuse;
- 2. Change the state's obligation to engage in reunification efforts when a child has been exposed to drugs; and
- 3. Significantly shorten the time to begin terminating parental rights under such conditions.

Notable features of House Bill 918, a/k/a the "Expedite Permanency" bill, include:

- Placement based on the best interests of the child, including attachment and developmental needs of the child.
- Due diligence to locate and identify adult relatives within 30 days of a child entering state custody. ... continued on page 3

WELCOMING NEW STAFF: Tina Gill

To learn more about the foster care system, in 2019, Tina also became a Guardian Ad Litem.

Tina says she is "passionate about helping children from hard places and looks forward to working with AGAPE and new foster families."

NC HOUSE BILL 918 . . . cont'd from pg. 2

- Prospective permanent placement within 1 year for children who enter state custody because of the birth parents' use of illicit substances.
- Designating a foster family, with whom a child has resided for at least 9 months, as "non-relative kin," eligible for permanent placement of the child (after consideration of other birth family members like grandparents).
- Allowing a foster family, with whom a child has resided for at least 15 months, to petition for termination of parental rights.

• Declaring that a birth parent's toxic exposure of a child in utero to non-medical drugs constitutes "aggravated circumstances" so that continued efforts for reunification would not be required unless the birth parent is enrolled in, and is meeting or exceeding the benchmarks of, a drug abuse treatment program.





This legislation was proposed in the NC House of Representatives in April 2019 and reviewed by various committees there. The House passed its bill in May 2019 and it was sent to the NC Senate. Following review by additional committees there between August 2019 and mid-2020, an Amended Bill (in its 4th Edition) eventually passed the Senate in June 2020. The House ratified that Amended Bill (4th Ed.) by the end of the month and presented it to the Governor's Office, where it was vetoed on July 2, 2020.

Governor Cooper shared the following statement on his veto: "House Bill 918 discourages pregnant women with substance use disorders from seeking treatment and prenatal care, risking their health and the health of newborns. And while it penalizes pregnant women with substance use disorders, it does nothing to expand access to treatment. This would disproportionately impact women of color and low-income women, who are already less likely to have access to the substance use treatment and quality healthcare they need."

So far, the NC Legislature has declined to vote on trying to override the Governor's veto and HB 918 now sits with a House committee again. Will it be revisited sometime soon?

Controversy remains. HB 918 could impact the rights of birth parents troubled with substance abuse to take the



time necessary to recover and get their lives in order, which is often at odds with the rights of their children to live less chaotic lives in foster care or to be permanently adopted. The divide is ideological and trying to achieve a balance is difficult and delicate.

Ironically, both advocates and opponents of HB 918 cite a growing body of brain science research that emphasizes:

- the importance of early childhood bonding with caring, attentive adults during the critical ages of 0-3 to promote neurological development; and
- how trauma during those years sets up children for a lifetime of psychological and physical challenges.

When one or both birth parents are substance abusers, should the goal of foster care be ultimate reunification of a child with his or her birth family, or should it be providing the most stable environment for the child as early as possible?

AGAPE of NC is interested in resolving for the best of both.
